Co-President's Message October 2017 Pat Proctor

Changes to the government are very slow. At the recent Leadership Conference, we were told that 200.000 messages were sent on behalf of AAUW to State and Federal legislators in the year 2016 as an attempt to influence legislation on behalf of women. As a glaring example of how we women never give up, the 19th amendment giving women in the U.S. the right to vote took 41 years to be passed from the first time it was introduced in 1879 to passage in 1920.

Voting, then considered a privilege, is sometimes taken for granted in 2017. Your vote does count, particularly on the local level. A school board election may seem insignificant but it is an important one. Our tax dollars and property values are huge considerations that should concern us all.

By now you will have received your ballot and hopefully have done the research to make an informed decision. We are fortunate in Douglas County to have the ballots mailed and to have ample opportunities to obtain information about the candidates and their platforms. Be sure to exercise the voting privilege that our suffragette women worked so tirelessly to obtain. Send in your ballot.

Some excellent branch programs are planned for the rest of the year. The next branch meeting will be on November 15 at the PSM library at 6:30 p.m. Our speaker will discuss Identity Theft which has been much in the news of late. It is way in the future, but consider attending Public Policy Day on Feb 3. This year the event will take place in Golden. The speakers are generally outstanding and well worth hearing.

Douglas County AAUW Scholarship History

Last year I reviewed the history of our branch's scholarship program and I shared some facts in the newsletter last September. I have updated that article and am sharing the updated version with you this year in honor of our branch's 40th year celebration.

While fundraising for scholarships was always one of our organization's goals, it appears that 1985 was the first year a scholarship was awarded by our branch to a Douglas County woman. Thus 2017 marks the **32st year** that our branch has awarded some type of financial support for women pursuing college degrees.

We are missing data and names of scholarship winners for seven intermittent years. However, available historical data reveals diversity in both institutions attended and college majors being pursued.

Higher Education institutions attended by Douglas County AAUW Scholarship winners include:

Arapahoe Community College, Regis University, Columbia, Metropolitan State University, University of Colorado (Denver), University of Colorado (Boulder), Colorado College, University of Phoenix, Community College of Denver, University of Colorado (Colorado Springs), Colorado School of Mines, Denver School of Nursing, University of Denver, American University Washington College of Law, University of Colorado (Anschutz Medical Campus), University of Northern Colorado, Colorado State University

College majors declared by our Scholarship awardees:

Accounting, Architecture, Biology, Business/Finance, Chemical & Biological Engineering, Child Health Program, Civil Litigation, Communications, Educational Leadership, English, Elementary Education, Fine Arts, Health Care Administration/Management, Human Resource Administration/Management, Mathematical Economics, Mechanical Engineering, Mental Health, Music Education, Nursing, Occupational Therapy, Psychology, Public Administration, Spanish, Teacher Education, Women's Studies

In early years, our branch awarded one scholarship annually. In recent years, due to ambitious fundraising, we have been able to award up to three scholarships annually. The 2017 Scholarship Committee (interviewers: Jean Kovatovich, Carol Murphy, Nedda Altschuld, Kendra O'Hayre) completed the selection process which included screening 12 applications and interviewing 6 highly qualified applicants before making a final decision. We were very excited to introduce the winning group to our membership at our September 20th branch meeting!

Scholarships Awarded, 2017

Once again thanks to our branch's successful fundraising activities, we were honored to award scholarships to three very deserving Douglas County women at our September 20th meeting. The \$1500 scholarships were presented to *Leah Porter, Gretchen Stulock,* and *Lauren Hallstrom*.

Leah's story is especially inspirational because she faced significant family challenges in the pursuit of her education. Leah grew up in Malaysia, the fourth of five girls in her family. She defied her father by becoming the first person in her family to graduate from high school. Leah's determination to follow her dream of higher education led her to Singapore and then Colorado with her husband ten years ago. Now a single parent, Leah continues to demonstrate amazing perseverance in reaching her goals. Last spring Leah completed her Associates Degree at ACC in Business and is now enrolled at UCD to earn a bachelor's degree in Business Management/Human Resources. Not only has Leah earned a 4.0 GPA while raising two daughters, she has demonstrated great leadership at ACC by serving as President, Vice Chair, and Representative on many local and state Community College advisory boards and committees. Leah has also earned numerous awards and accolades for her volunteer efforts. She is a whirlwind of positive energy directed toward the advancement of her future career and the advancement of opportunities for the underserved. So, it is especially humbling that our AAUW organization can play an important part in helping Leah achieve her career goals!

Our second scholarship recipient, Gretchen Stulock, is described by a colleague as "one of the most conscientious, creative, and passionate teachers I have known. She is constantly trying to make literature meaningful to them (students) and give them opportunities to see social justice and injustice in the works she is teaching and in the current world in which we live." Gretchen comes from a family of educators and is currently teaching at Littleton High School—the school from which she graduated. Over the past three years, Gretchen has taught a variety of courses in the Language Arts Department including an International Baccalaureate course and a course for students with special needs. Gretchen is dedicated to her English teaching career and is pursuing a Master's Degree at UNC in Curriculum Education because she wants to "hone her craft, to be a master teacher." Another colleague commented that Gretchen continually searches for ways to get involved and grow as an educator---chaperoning a student trip to Costa Rica where her Spanish speaking skills were a true asset; serving as a facilitator of a Professional Learning Community; sponsoring a school Greenhouse Club. However, Gretchen's passion also extends to her role as a highly skilled cellist for several theater groups and with the Denver Trio Project. Gretchen understands how to keep her life in balance while advancing her career goals. She is a model for all young teachers and for all women who are in the early years of their careers. We are pleased to support Gretchen in her continued journey in education. Education is a powerful tool in the hands of teachers like Gretchen! (Continued on next page)

Our third scholarship winner is a young woman of incredible talent and potential, Lauren Hallstrom. As a junior at CSU, Lauren is focusing on English, Creative Writing specifically. What sparked the creative writing talent in Lauren? Undoubtedly it is the result of many positive influences in her life as well as a gift for words. One influence may have been Parker Library which was the recipient of many volunteer hours by Lauren over the past seven years. Her work as a Reading Buddy, as a mentor for children struggling with reading, as a volunteer at many library outreach events, as a trainer for other volunteers...all this and more led to the Parker Library hiring Lauren as its first teenage employee. Perhaps being around all those books and book lovers had an influence on this creative young woman. Words seem to inspire Lauren or perhaps Lauren's skill at putting thoughts into words inspires the reader! At the age of fifteen, Lauren published two CIPA-EVVY award-winning middle grade and young adult novels. She worked with a graphic designer, editor, and publisher to publish Dreamweaver in 2013 and One Hundred Words in 2014. In 2015 Lauren placed 1st in the Colorado Independent Publishers Association and received the Gold Award in the Juvenile Fiction category for her second published novel. Many additional awards and recognitions have been bestowed on this talented author. Although Lauren excels at writing, she takes time to share her passion for writing and the power of words with other younger students, fellow students, and her university teachers. Lauren's goal is to become a Youth Librarian. She wants to spend her life impacting her community and she realizes that libraries bring people together. We are inspired by Lauren's dedication to writing and by her past and current success. We wish her the very best as she continues along her career path and we know her work will continue to be recognized for its excellence!

Our branch is honored to support the dreams, education, and career goals of these three women. We thank them for their dedication to their careers and to making their communities and the world a better place for all of us. We wish them the best and hope to hear from them in the future.



Would you support school reform plans, vouchers, and other initiatives that would permit parents to use public funds to send their children to private elementary and secondary schools?

We've seen many stories in the news nationwide about the bullying of LGBT and gendernonconforming students. What policies and trainings to you believe should be implemented to protect these students from harassment?

What resources and support are available for pregnant and parenting students in our schools?

What are your top three objectives if you are elected to the school board?

What topics do you believe are appropriately covered in family life or health education courses?

With what organizations are you affiliated, which organizations have endorsed or sponsored your candidacy, and which organizations have you asked to endorse your campaign? How are you raising money for your campaign?
