#### LAF ADVOCACY FUND

The Legal Advocacy Fund (LAF) works to challenge sex discrimination in higher education and the workplace. Resources range from community outreach programs to the backing of major legal cases.

Sex discrimination today takes a variety of forms: unfair pay, pregnancy discrimination, sexual harassment, sexual assault, and violations of Title IX of the Education Amendments of 1972 which can affect both women and men. LAF addresses these barriers by informing people of their rights and using the legal system to seek justice and change.

Since its inception, LAF has funded and supported plaintiffs in landmark cases as well as cases with the potential to set future precedents. Recently the 2017 LAF committee and AAUW board voted to adopt several new cases that may change the landscape for women and girls.

#### Co-President's Message November 2017 Beryl Jacobson



Recent headlines make me feel that I belong to an organization that is on the cutting edge of societal problems and trying to make a difference by helping solve them.

Our November meeting will be about Identity Theft with Barbara Martin Worley from the District Attorney's office as our guest speaker. What a timely topic our program committee has chosen with the recent Equifax data breach, from mid-May through July, that exposed the personal information of 143 million Americans. The hackers accessed people's names, social security numbers, birth dates, addresses, driver's license numbers and the credit card numbers of 209,000 people. Learn the steps you can take to help protect your information from being misused as you listen to and ask questions of our November speaker.

Go to our AAUW national website <a href="www.aauw.org">www.aauw.org</a> and you will find helpful information under the heading Know Your Rights: Workplace Sexual Harassment that you can pass on to help others who find themselves being harassed. Our Douglas County affiliate sends \$30. per member yearly to the AAUW Fund to be used to fund the research behind information, such as this. The AAUW Fund is an umbrella fund with part being distributed to the Legal Advocacy Fund which provides programs such as "Legal Case Support, Finding Legal Help, Know Your Rights at Work and on Campus, Case Support, Travel Grants and Campus Outreach Grants". Sexual harassment has been in the news lately with the New York Times story about Ashley Judd that unearthed what would become more than 40 accusations of sexual harassment and in some cases assault against movie titan Harvey Weinstein. In the story, Judd said "Women have been talking about Harvey amongst themselves for a long time and it's simply beyond time to have the conversation publicly." With the flood gates opened, Judd is optimistic we are going to see change. She suggests that Human Resource Departments may not be the place to go since the staff work for the company. She has set up a <a href="Gift of Courage Fund">Gift of Courage Fund</a> to help outside organizations, like AAUW, that are helping women with these issues. In a post on Instagram, actress Minka Kelly wrote, "No more Harvey Weinstein in Hollywood does not solve the problem but maybe more voices sharing their stories and adding support to the countless women and men who have suffered through abuse of power, the less it will be tolerated".

In Colorado, our state organization is encouraging us to collaborate with other organizations that have similar goals. Since our October program was designed to help us be informed voters about our Douglas County School Board Election, Julie Reagan our Program VP and Char Sholes collaborated with the League of Women Voters to get us involved with the candidate forum they sponsored. Nine of our members attended, on October 3, at the Lone Tree events center and handed out cards for attendees to use for their questions.




# LAST DAYS OF NIGHT by GRAHAM MOORE

(recommended by Linda Washburn, evening book club)

Great inventors take the stage in this historical fiction/legal thriller based on the lighting of New York City in the 1890s. The story is told by Paul Cravath, an attorney hired by George Westinghouse to take on Thomas Edison in a battle over lightbulb patents. The setup may sound dry, but Graham's pacing keeps the story driving forward. There are crimes. There's a mysterious woman. There's a mad genius in the form of Nikola Tesla. And it's all set against the backdrop of the glittering Gilded Age. Every so often an historical fiction comes along that captures the imaginations of legions of readers. ### The Ledge

In June 1992, best friends Jim Davidson and Mike Price stood atop Washington's Mount Rainier, celebrating what they hoped would be the first of many milestones in their lives as passionate mountaineers. Then their triumph turned tragic when a cave-in plunged them deep inside a glacial crevasse—the pitch-black, ice-walled hell of every climber's nightmares.

An avid adventurer since youth, Davidson was a seasoned climber at the time of the Rainier ascent. But the harrowing free fall left him challenged by nature's grandeur at its most unforgiving. Trapped on a narrow frozen shelf, deep below daylight, he desperately battled crumbling ice, snow that threatened to bury him alive, and crippling fear of the inescapable chasm below—all the while struggling to save his fatally injured friend. Finally, alone, with little equipment and rapidly dwindling hope, he confronted a fateful choice: the certainty of a slow, lonely death or the near impossibility of an agonizing climb for life. A story of heart-stopping adventure, heartfelt friendship, fleeting mortality, and implacable nature, *The Ledge* chronicles the elation and grief, dizzying heights and punishing depths, of a journey to hard-won wisdom.

#### History and Culture Trip to Loveland

Natalie Weber arranged a fascinating trip to Loveland to learn about bronze sculptures. Sandy Monticello, Pat Proctor and Nedda Altschuld joined Natalie for a guided tour at Art Castings of Colorado, which is one of the foremost art foundries in the country, for bronze and stainless steel sculptures. We were able to see the "lost wax" casting process in action. It begins with a liquid rubber mold from the original clay or wax sculpture that the artist has created. We witnessed all steps in the process, including wax pouring, wax chasing, spruing, as well as the impressive metal pouring process, in which molten bronze is very carefully poured into the shell. This is followed by welding, metal chasing and the application of patina.

Afterwards we had a delicious lunch at Door 222, located in Loveland's historic district. Then we met George Wallbye at the Benson Sculpture Gardens. He guided us around the gardens, showing us some of the 154 permanent sculptures acquired/maintained through the efforts of the Loveland High Plains Arts Council and many volunteers. George is a renowned sculptor himself and has several pieces at the Gardens. He is a charming guide; he had humorous stories and facts about the artists and their works. The Sculpture Gardens are the site of a nationally recognized sculpture show held since 1984, in August.

If you ever have a chance to go to the Art Castings Foundry or Benson Gardens, or attend the annual show (and say hello to George) you should do it!


