Annual Meeting

Thank you to the 30 members who attended our annual meeting on May 16 at the Charles Schwab campus. We were given a talk with an opportunity to ask questions and then a short tour. We were amazed to learn that the campus houses 4,400 employees who work at standing desks with shoulder height partitions that allow them to have views to the outdoors through all the windows. When asked about working conditions for women, we were told that each position has a salary attached to it that doesn't vary based on gender. There is a generous family leave policy. Women employees can choose to belong to WINN, a women's networking group that plans programs to address women's issues.

We went outside to view the extensive gardens that incorporate a drainage system and are terraced down with walls that are suitable for seating. Charles Schwab encourages charities to use the space for fund raising efforts that are open to the public. Many of those present asked about bringing friends and family on to the campus for one of these events. Maressa MacClintock, our event coordinator, sent these details about events upcoming this summer.

Co-President's Message June 2018 Beryl Jacobson



After three years serving on the board as incoming president, co-president with Marcia Miller and co-president with Pat Proctor, my term has ended. We no longer have a board position for incoming president but we do for Co-President. At this time, it is vacant. It was invaluable for me to work with Marcia Miller to learn about the job of president. Pat Proctor has been so easy to work with. I know that if you step up to join her, you will have an enjoyable year with a sense of volunteering for a worthwhile organization. We also need a Historian and a Hospitality Committee member. Think about calling Pat and saying yes to one of these positions. We also need a chair for our Christmas Party.

At the National level, we heard from Julia Brown at our State Convention. It made me proud to have her as our national president. She talked about the Strategic Plan that is being developed. It will help us answer three simple questions: Where are we now? Where do we want to be? and How will we get there? Affiliates can do planning in the same way by starting with the big picture and then narrowing it down, planning immediate goals and then a few focused goals. The new Strategic Plan will have 4 areas of focus to direct our path. They are: Education and Training, Economic Security, Leadership and Governance and Sustainability. The national board is hoping that if the vote allows those without a degree to join, it will help us to attract and retain a more diverse membership. Julia said that we need to adapt, evolve, and change. She suggested we find other organizations in our community with a similar mission to partner with.

At the State level, we have hired a communications firm for 4 months. They will audit state communication tools for best practices, finalize a marketing plan and provide tools to make branch communications easier. Plans are being made for the Fall Leadership Conference. The State is offering a \$110 scholarship for four first time attendees.

At the local level, we are transitioning board members. To make this easier, we are scanning papers and putting the information into electronic folders that can be transferred through a flash drive. We are thinking of ways to fund our Scholarships. Finally, plan to attend the Summer Picnic and bring items for our silent auction. I'm bringing a certificate to pick up Rotary Peaches.

COLORADO HISTORY AND CULTURE CLUB GLEN EYRIE CASTLE

From the rich heritage of General Palmer, the founder of Colorado Springs, to the deep spiritual legacy of The Navigators (an interdenominational Christian ministry), the guided Historical Tour takes you on a journey filled with stories of rival turn-of-the century railroad wars and oil tycoons to what is now the soul-stirring property of Glen Eyrie.

The tour tells of the history of General Palmer and The Navigators, and includes a Guided Walking Tour through the Carriage House and the first and second floors of The Glen Eyrie Castle. After building a large carriage house, where the family lived for a time, Palmer and his wife Mary (Queen) Mellen built a 22-room frame house on the 800-acre estate. The house strongly resembles stone <u>castles</u> reminiscent of those native to <u>England</u>. The castle includes many "modern day conveniences" and reflects General Palmer's innovative visions.

Our tour guide included historical information and anecdotal accounts with her own reflections of the family to create an inspiring story of the Palmers. It is a worthwhile tour and you can arrange to stay for afternoon tea or overnight at the B&B.

FUNDRAISER

Most of the funding for the Higher Education Scholarships and the High School STEM Awards has for the past several years come from our primary fund raiser, Tacos and Tunes, held in August. Generous donations from our members and many community businesses have allowed us to conduct a very profitable silent auction and award other prizes. The auction and ticket sales for this event have been extremely successful.

Because of the change of ownership and renovations taking place at the Plum Creek Golf Club, it has become necessary to find a new venue for this year. Catering costs everywhere have risen to the extent that ticket prices would have to be increased in order to sustain a profitable fund raiser.

Typically, we have asked each member to sell or purchase 2 tickets at a total cost of \$50. We have also called upon our membership to solicit merchants for donations and contribute items for the silent auction.

All things considered, the executive board finds that instead of sponsoring this event, we ask that each member donate a minimum of \$50 by August 1 for the purpose of supporting the Awards and Scholarships. A larger amount would be wonderful.

Each year the Public Policy Committee of Colorado reviews the bills that are to come before the legislature and takes a stand to actively support, monitor, oppose and actively oppose issues that relate to the mission of AAUW. A review of the legislature site shows the following results for the bills that our organization actively supported during the most recent session:

- Rural School District Teaching Fellowship Programs-sent to the governor
- Employee Leave to Participate in Elections-postponed
- Additional Public School Capital Construction Funding-sent to the governor
- Funding for Full Day Kindergarten-postponed
- Expand Child Nutrition School Lunch Protection Act-sent to the governor
- Contribution Limits for School District Directors-postponed
- Financial Incentives for Education in Rural Areas-sent to the governor
- DPS Human Trafficking Related Training-postponed
- Increase Surcharge for Trafficking Children-governor signed
- Protection Minor Victims of Human Trafficking-postponed
- Family Medical Leave Insurance Program-postponed
- Opioid Misuse Prevention-governor signed
- Continue Child Care Tax Credit-sent to governor
- Task Force for Youth Experiencing Homelessness-postponed
- Training Program Prevention Child Sexual Abuse-sent to the governor




A Kind of Mirraculas Paradise A True Story About Schizophrenia

Writer Sandra Allen did not know their uncle Bob very well. As a child, Sandy had been told Bob was "crazy," that he had spent time in mental hospitals while growing up in Berkeley in the 60s and 70s. But Bob had lived a hermetic life in a remote part of California for longer than Sandy had been alive, and what little Sandy knew of him came from rare family reunions or odd, infrequent phone calls. Then in 2009 Bob mailed Sandy his autobiography. Typewritten in all caps, a stream of error-riddled sentences over sixty, single-spaced pages, the often-incomprehensible manuscript proclaimed to be a "true story" about being "labeled a psychotic paranoid schizophrenic," and arrived with a plea to help him get his story out to the world.

In A Kind of Mirraculas Paradise: A True Story about Schizophrenia, Sandy translates Bob's autobiography, artfully creating a gripping coming-of-age story while sticking faithfully to the facts as he shared them. Lacing Bob's narrative with chapters providing greater contextualization, Sandy also shares background information about their family, the culturally explosive time and place of their uncle's formative years, and the vitally important questions surrounding schizophrenia and mental healthcare in America more broadly. The result is a heartbreaking and sometimes hilarious portrait of a young man striving for stability in his life as well as his mind, and an utterly unique lens into an experience that, to most people, remains unimaginable.

Called "an act of radical empathy" by Anne Fadiman and "a truly original piece of work" by Adrian Nicole LeBlanc, *A Kind of Mirraculas Paradise* is a propulsive, stunning book that's poised to change conversation about schizophrenia and mental illness generally.



In the Midst of Winter

In the Midst of Winter begins with a minor traffic accident—which becomes the catalyst for an unexpected and moving love story between two people who thought they were deep into the winter of their lives. Richard Bowmaster—a 60-year-old human rights scholar—hits the car of Evelyn Ortega—a young, undocumented immigrant from Guatemala—in the middle of a snowstorm in Brooklyn. What at first seems just a small inconvenience takes an unforeseen and far more serious turn when Evelyn turns up at the professor's house seeking help. At a loss, the professor asks his tenant Lucia Maraz—a 62-year-old lecturer from Chile—for her advice. These three very different people are brought together in a mesmerizing story that moves from present-day Brooklyn to Guatemala in the recent past to 1970s Chile and Brazil, sparking the beginning of a long overdue love story between Richard and Lucia.

Exploring the timely issues of human rights and the plight of immigrants and refugees, the book recalls Allende's landmark novel *The House of the Spirits* in the way it embraces the cause of "humanity, and it does so with passion, humor, and wisdom that transcend politics" (Jonathan Yardley, *The Washington Post*). *In the Midst of Winter* will stay with you long after you turn the final page.
